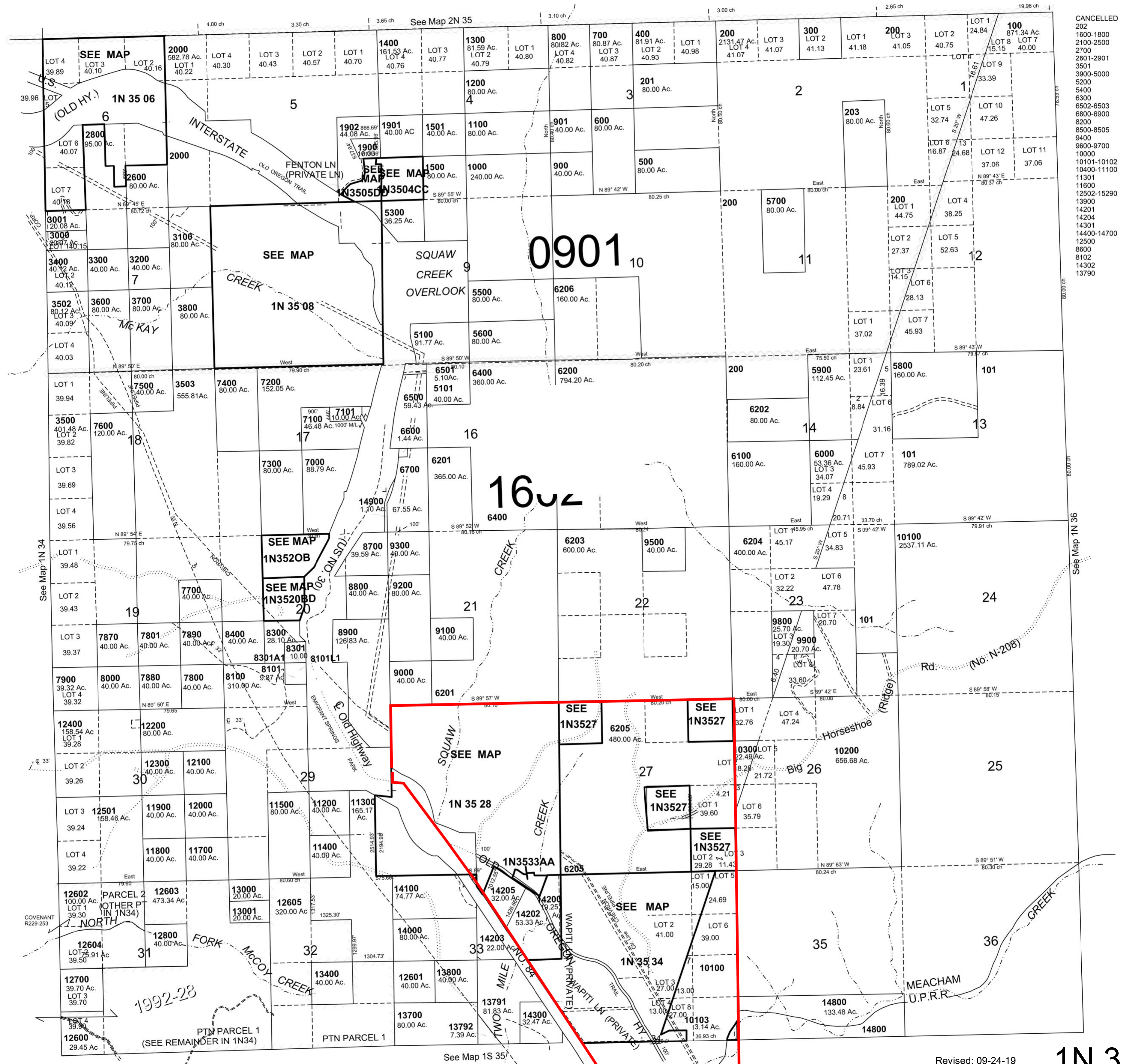

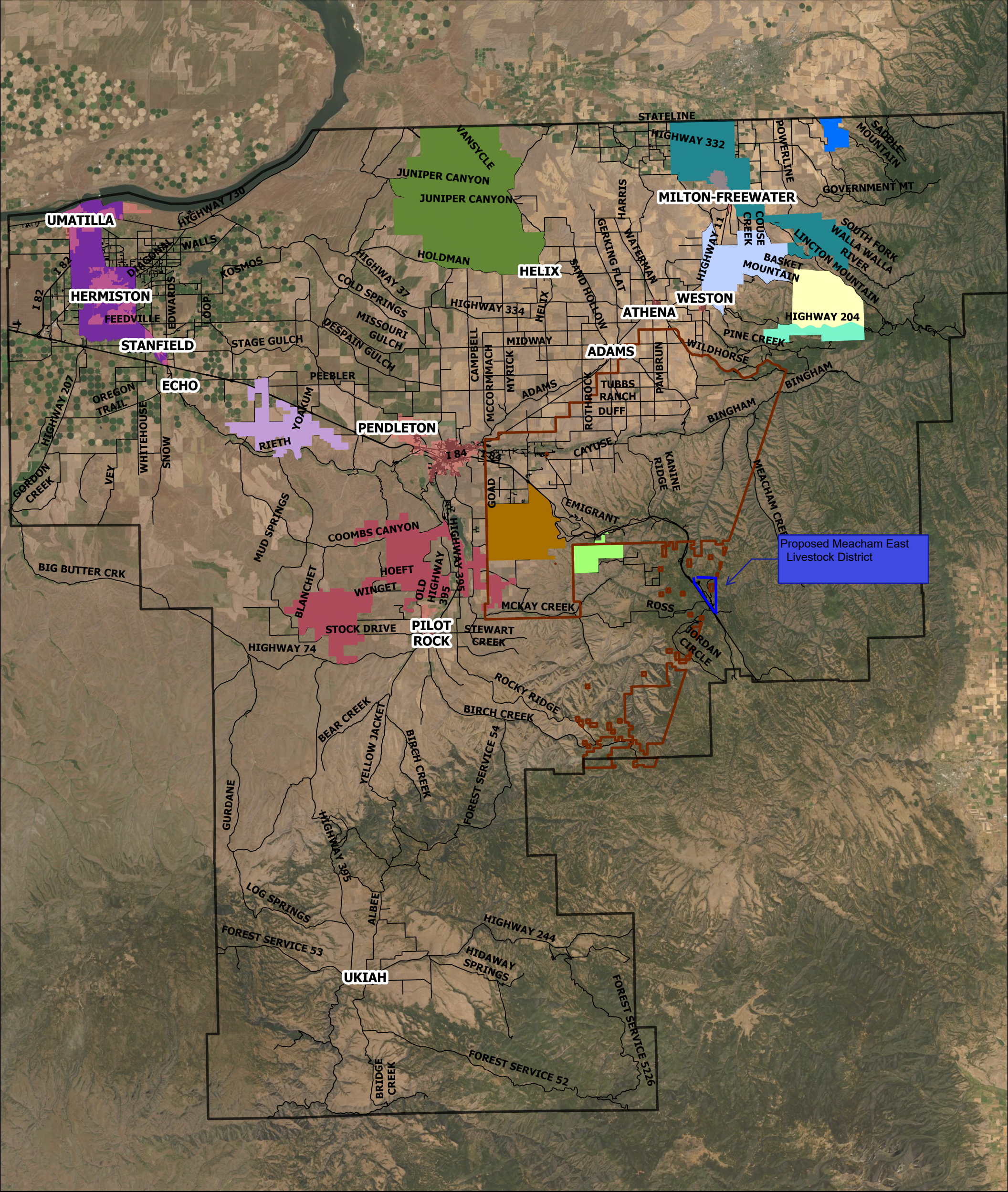

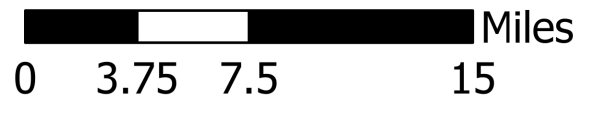


Livestock Districts, Umatilla County, Oregon

WHEREAS, in accordance with ORS 607.018, Umatilla County has received a petition from a property owner that owns property in an unincorporated area of the county that desires to create a livestock district to be known as the Meacham East Livestock District;

WHEREAS the proposed district contains not less than 2,000 acres;

WHEREAS the classes of livestock not be permitted to run at large within the proposed livestock district are animals of the bovine species, horses, mules, asses, sheep, goats and swine.

NOW THEREFORE, the Board of Commissioners orders that:

1. Umatilla County hereby finds the petition for formation of the Meacham East Livestock District meets the requirements under ORS Chapter 607 and the petition is accepted.

2. The boundary for the proposed Meacham East Livestock District is as follows:

All portions of Sections 27, 28 and 34, Township 1 North Range 35, lying East of Interstate 84, and portion of Section 3, Township 1 South, Range 35, lying East of Interstate 84, all being East of Willamette Meridian, Umatilla County, Oregon.

3. A hearing will be held on October 20, 2021, at 9:00 a.m., in Room 130, Umatilla County Courthouse, for a hearing on the petition for creation of the Meacham East Livestock District.

4. A notice of the hearing will be sent by certified mail to the applicant and to owners of record of property located within the proposed district and others as set out in ORS 607.018.

5. Notice of the hearing shall be published in the East Oregonian, a newspaper of general circulation in Umatilla County, once a week for two successive weeks.
