- The enabling statutes, or principle act, of a district specifies how district board members are elected. Most districts, as defined in ORS 255.012, elect board members at the regular district election which is held in May of odd numbered years. As provided for in ORS 255.235(2)(a), the March, September and November deadlines included above are only applicable if the election is a district's first election to elect board member and do not appear on the daily calendar.

Form may only be filed upon completion of the ballot title challenge process.

Form may only be filed upon completion of the ballot title challenge process.				
→ Form SEL 803 Notice of Measure Election - District	January 12	March 16	July 20	September 7
Form may not be filed until after the deadline for the immediately preceding election has passed. Additionally, completion of the ballot title process, including publication of receipt of ballot title and any challenge process, may occur after the filing deadline.				
After receipt of form SEL 803, the County Elections Official must publish notice of election in the next available edition of newspaper in electoral district unless otherwise required by charter, ordinance and/or statute.				
Last Day to File with County Elections Official → arguments for inclusion in county voters' pamphlet	January 17	March 20	July 24	September 11

- For resubmitted measures the deadline is 47th day before the election; the measure argument filing deadline is 2nd business day after deadline to resubmit measure, if the county includes the resubmitted measure in the county voters' pamphlet.

- Deadlines applicable to county and city office are not included on this calendar. Candidates for those offices, unless otherwise provided for by charter or ordinance, are elected at the primary or general election. If a county or city charter provides for candidates to be elected at an election other than the primary or general election but does not specify a deadline or adopts the statutory filing deadline, ORS 249.722 applies.
