*ALL OCCUPANTS MUST PURCHASE FAIR ADMISSION TICKETS – CAMPING FEES DO NOT PROVIDE FOR FAIR ENTRY. CONTACT THE FAIR OFFICE TO OBTAIN EXHIBITOR PASSES AT A REDUCED RATE.

*ONCE YOUR RV IS PARKED, THE TOWING VEHICLE MUST BE REMOVED AND PARKED AT A DESIGNATED LOT ON THE FAIRGROUNDS. SEASON PARKING PASSES FOR OVERNIGHT LOTS MUST BE OBTAINED THROUGH THE FAIR OFFICE.

*NO PERSON ATTENDING THE UMATILLA COUNTY FAIR SHALL CONSUME OR POSSESS ANY CONTROLLED SUBSTANCE. ONLY ALCOHOL OBTAINED FROM A DULY AUTHORIZED FAIRGROUNDS CONCESSIONAIRE IS PERMITTED. **2017 CAMPING INFORMATION FOR THE FIRST FAIR AT THE NEW FAIGROUNDS
LOCATED AT THE EASTERN OREGON TRADE & EVENT CENTER (EOTEC)
1705 E AIRPORT RD. HERMISTON, OR 97838**

- A full service RV camping facility will **not** be completed in time for our use during the 2017 fair.
- Water will be available but plan on using hoses and Y connections to access the available tap points.
- Water installation and materials are anticipated to be provided by volunteers and sponsors after primary fairgrounds construction is declared substantially complete. That is anticipated to be in mid-JULY.
- Sewer hookups/cleanouts will not be available. Future site development plans include sewer lines and an additional building for toilets and showers within the central area of the RV parking.
- The contracted portable toilet supplier will be available to pump RV's upon request through the main office. RV pumping will remain at \$20 per pump.
- New bathrooms and showers will be available on the South end of the Small Animal Barn (which is the closest building to the RV sites).
- For your convenience, additional portable toilets will be placed at points within the RV site.
- Expect to bring your RV generator. Access to power is unconfirmed at this time.
- The RV site is on a natural surface that will be mowed down prior to move-in. It is not asphalt or gravel.
- Access to the RV site will be via OTT Road on the Northeast end of the fairgrounds.
- We have reduced the price for a season parking pass from \$40 to \$20 for vehicles that will remain on the fairgrounds during fair week. There will be a designated lot on the fairgrounds for season parking passes.
