

## Report, Survey and Plat of Co. Road from State Line on Dry Cr.

## Road near Rice's Ranch

Wasatch County Oregon August 3<sup>rd</sup> 1872

At the Court of the County of Wasatch County Oregon

The undersigned citizens of your County appointed by your board at your July term to view out and survey a road from the State Line near where the State line crosses Dry creek thence up said creek to State road at George Sargents thence along said road to the SW corner of S B 20 of Sec 11 Town 11 N R 36 E thence to the West fork of Dry creek near where the road now crosses thence up said creek to its source to connect with the County road leading from the store to Section 36 of Rice's ranch & with my leave to report that on the 31<sup>st</sup> of July they left home and on the first of August that we met at the house of James Fruit and proceeded to the State line and after being duly sworn James Fruit with his wagon carrying stakes and G Fruit & J Naunoth as chainmen proceeded as follows setting a large stake marked S. L. we ran as follows S. 10 E. 8 ch. to rise of ground S 45 E 27 ch. to the corner of J. Fruit's fence thence East 17 ch S 35 E 37.50<sup>th</sup> thence S. 65 E. 15.50 one mile post thence N 70 E 30 ch S 75 E 8.00 S 60 E 24.50 East 20 ch 2 mile post S 60 E 40 ch S 55 E 30 S 40 E 10 to 3 mile post continue at 45 E. 80 ch to 4 mile post continuing S 45 E. 80 ch to 5 mile post continued S 45 E 27 ch we descend to creek bottom and continue up creek keeping all ranches to our right as follows S 65 E 58 ch to 6 mile post S 66 E 34.00<sup>ch</sup> N 70 E 8.00<sup>ch</sup> S 45 E 31 ch S 47 E 4 ch to 7 mile post S 46 E 80 ch to 8 mile post S 10 E 30 ch 9 mile S 32 E 30 ch S 26 E 47 ch 10 mile continue 80 ch to 11 mile stake S 22 E 17.50<sup>ch</sup> to NE corner of W M Steens field S 10 E up fence 60.00<sup>ch</sup> to 12 mile stake 14 chain to State road thence with State road at 35 ch pass Geo. Sargents On the second day we continued said road 45 chain & set 13 mile post continued on State road set 14 mile post at 67.25<sup>ch</sup> struck Barretts SW corner. Procured J D Odell to carry chain & G Fruit as aranger & ran East on Barretts south line 17.70 set 15 mile post continued East 4 ch thence S 44 E 60 ch to corner of Hanson on West Dry creek thence East crossing creek where the road now crosses said creek 19 ch to corner of fence on present road thence S 38 E 11 ch S 22 E 20 ch S 20 E 15 ch
