

Field Notes of Road #541 .

IN Accordance with an order issued by the Honorable County Court of Umatilla County at its May term 1902. I met J. S. Mcleod J. Barnhart and B. F. Remm at the Court House in Pendleton on June 1902 and after qualifying as viewers and surveyor we proceeded to the initial point of Road 541. We called to our aid B. Hopper and J. Barnhart as chainmen and C. E. McComber as marker and proceeded to locate and survey aforesaid Road.

Beginning at a point on Road 265 where said road intersects the Township line between Township 2 and 3 North and Range 30 E. W. M. on the line between sections 1 and 36 From which point, South 30 feet distant I set Post marked R 541 with mounds and pits as per instructions

1 & 2, and set post 30ft. North marked R. T. 541, as per instructions.
