## REPORT OF BOARD OF COUNTY ROAD VIEWERS.

IN THE MATTER OF VIEWING, SURVEYING AND LAYING OUT COUNTY ROAD NO. 659  
TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY.

WE, THE UNDERSIGNED Board of County Road Viewers, heretofore instructed to  
view, survey, and locate Road No. 659 submit the following report:

Pursuant to an order of the Honorable County Court we met at County Sur-  
veyors office in Pendleton, Oregon, on the 29th day of May, 1908.
