(unmarried)

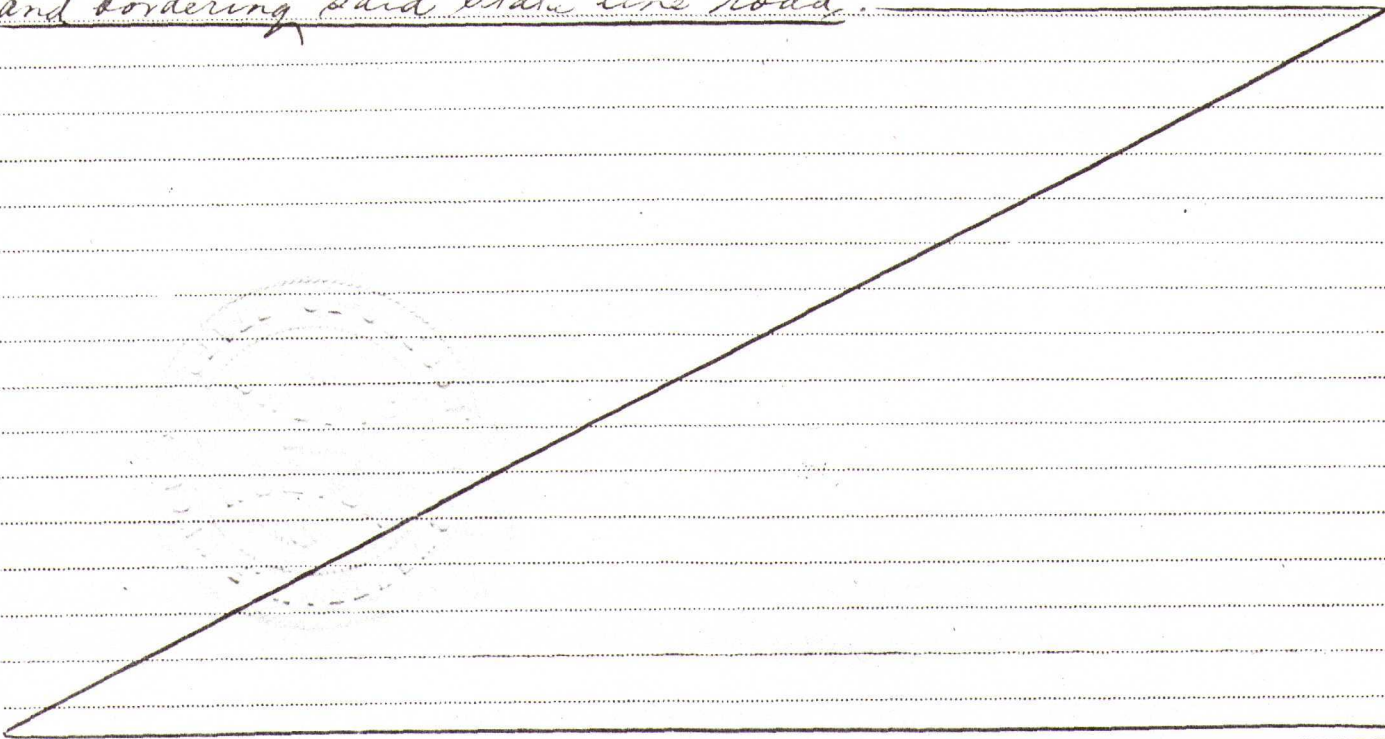
for the consideration of the sum of One hundred seventy one and no/100 DOLLARS,

situated in Umatilla County and State of Oregon to-wit:
Commencing at a point fourteen hundred eighty five and 1/2
(1485 1/2) feet west of the intersection of the North and South
center line through the center of section fifteen (15) Township
six (6) North Range thirty-five (35) E. T. M. on the South side of
the State line road between Oregon and Washington, running
thence West along the South side of said road nine hundred
eighty-eight and 1/2 (988 1/2) feet more or less to the West line
of our premises as described in deed dated Aug 22, 1907 and
recorded in Book 54 Page 495 records of deeds of said County,
thence South along said West line fifteen (15) feet, thence
East and parallel with said State line road between
Oregon and Washington nine hundred eighty eight and 1/2
