have granted, bargained, sold and conveyed, and by these presents do.....grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 40 feet wide, being twenty feet wide on each side of the center line of the survey as surveyed over and across the following described land: Beginning at a point which point is 1320 feet east and 2080 feet north of the section corner common to sections 25, 26, 35 and 36, township 5, north range 36 E.W.M.; thence along a tangent in a southeasterly direction a distance of 90 feet; thence around a 12° curve left a distance of 252.2 feet; thence along a tangent in an easterly direction a distance of 84.1 feet; thence around a 28° curve right a distance of 204.4 feet; thence along a tangent in a southeasterly direction a distance of 194.4 feet; thence around a 12° curve left a distance of 115.1 feet; to a point in the center of the present road, which point is 1320 feet east and 760 feet south more or less from the point of beginning.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
