Staggs in the S. 1/2 N.W. 1/4 Sec. 11, Twp. 4 N., R. 35 E., W.M. included within a strip of land 70 ft. in width being 40 ft. on the right and 30 ft. on the left of the center line of the Oregon-Washington Highway as surveyed over and across said property, said center line being more particularly described as follows:

Beginning at a point approximately 2055 ft. South and 60 ft. East of the 1/4 sec. cor. common to secs. 2 and 11, Twp. 4 N., R. 35 E., T.M., Umatilla County, State of Oregon; thence on a continuation of a 15 degree curve to the right whose central angle is 33 degrees 48' 100 ft., thence N. 42 degrees 41' E. 132.4 ft., thence on a 20 degree curve to the left whose central angle is 60 degrees 54' 304.5 ft., thence N. 18 degrees 13' W. 292 ft., said tract of land containing 1.34 acres, more or less.
