paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land sixty feet wide, being thirty feet wide on each side of the center line of the Eagle Creek Market Road as surveyed over and across the Southwest Quarter of the Southeast Quarter of Section 22, Township 3 North, Range 35 East, W.M. Said center line being more particularly described as follows; Beginning at a point on the Section line 1600 feet south of the Quarter Section corner common to Sections 21 and 22, T. 3 N. R. 35 E. W.M., thence S. 56 25' E., 195.7 feet, thence on a curve to the left of radius 1432.7 feet, 190.0 feet, thence S. 64 01' E., 182.8 feet, thence on a curve to the right of radius 114.6 feet, 330.1 feet thence N. 78 59' W., 415 feet to a point on the Section line, 2030 feet south of the Quarter Section corner common to Sections 21 and 22. All in Township 3 North, Range 35 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
