All that part of the property of P. A. McBride and T. L. McBride and Ethel McBride, his wife, included within a strip of land sixty feet wide being thirty feet on each side of the center line as surveyed over and across said property.

Beginning at Station 202 4 00 of the Eagle Creek Highway Survey which Station is approximately 1320 feet North and 300 feet East of the Quarter Corner which is common to Sections 4 and 9 Township 3 North Range 35 East W. M. Thence running in a Southeasterly direction approximately 4272 feet to Station 245 4 72 of the said survey, which Station is approximately 147 feet South and 1320 feet East of the Center of corner which is common to Section 9 Township 3 North Range 35 East W. M.
