We the undersigned having been appointed by your Hon. body to view out and survey a change in said Road No 168 being at a point 200 yards South of 1/2 mile stake on the East boundary of Sec 7 Tp 5 N. R 33 E. and being on a N. westerly direction to intersect the six mile post.

We met at the time and place appointed and after being qualified according to law by A. C. Coffey County Surveyor, we called to our aid W. W. Caviness and G. B. Clarke as chairman and Benj Stanton as marker, we proceeded to view out and survey said Road as set forth in the Order, we find the proposed road a good practical road and easily opened and much needed.

We would ask that the petition for said road be granted, this 26<sup>th</sup> day of July 1883.

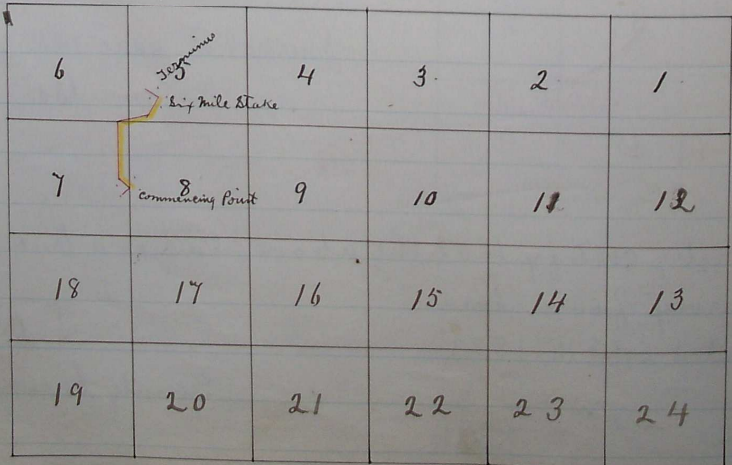
