Umatilla County, State of Oregon, to-wit: A strip of land 40 feet wide, being 20 feet on each side of the center line of the survey as shown upon the location map and described as follows, center line described: Beginning at a point at the center of the west boundary of section 25, Twp. 5 N, Range 32, E.W.M., thence north 89°26' East a distance of 290.2 feet; thence around a 28° curve left a distance of 250.2 feet; thence north 19°23' East a distance of 200.3 feet; thence around a 20° curve right a distance of 246.7 feet; thence north 68°44' East a distance of 229.3 feet; thence around a 10° curve left a distance of 241 feet; thence north 44°59' East a distance of 0.1 feet; thence around a 24° curve right a distance of 320.7 feet; thence south 82°24' East a distance of 673.5 feet; thence north 50°12' East a distance of 159.3 feet to the east boundary of said section 25.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
