unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 40 feet wide, being 20 feet on each side of the center line of the survey as shown upon the location map and described as follows, center line described: Beginning at a point 2846 feet west of the southeast corner of section 19, Twp. 5 N, Range 33, E. W.M.: thence north 50°12' East a distance of 255.9 feet; thence around a 3° curve left a distance of 406.7 feet; thence north 38°00' East a distance of 971.5 feet; thence round a 5° curve right a distance of 659 feet; thence around a 9° curve right a distance of 810.9 feet; thence south 36°04' East a distance of 356 feet; thence around a 20° curve left a distance of 509 feet; thence north 82°08' East a distance of 31 feet to the east boundary of said section 19.

This deed is intended to convey all rights, title and interest to the above mentioned right of way excepting the rights of the heirs to the Myrtle Scott estate.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
