KNOW ALL MEN BY THESE PRESENTS, That JESS S. ELWOOD and BERTHA G. ELWOOD, husband and wife,

grantor S, in consideration of One and no/100 ----- Dollars, and other good and valuable consideration to them paid by UMATILLA COUNTY, OREGON, a municipal corporation of the State of Oregon,

do hereby grant, bargain, sell and convey unto the said grantee, its successors, heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Umatilla and State of Oregon, bounded and described as follows, to-wit:

A strip of land 50 feet in width, 25 feet on each side of the center line of the Thornhollow Gibbon-Bingham Springs Road No. 435 as said county road has been relocated, which center line is described as follows:

Beginning at Engineer's center line station 486/00, said station being 738 feet South and 1370 feet West of the East quarter corner of Section 22, Township 3 North, Range 36 East W.M.; thence North 52° 59' East 192.5 feet; thence on arc of 1146.0 foot radius curve left (the long chord of which bears North 57° 49 1/2' East) 206.5 feet to the Engineers center line equation station 489/98.9 = 490/08.9 ahead; thence North 52° 40' East 338.5 feet; thence on arc of 636 foot radius curve right (the long chord of which bears North 60° 31 1/2' East) 174.6 feet; thence North 58° 23' East 111.3 feet; thence on arc of 358.1 foot radius curve right (the long chord of which bears North 82° 00' East) 170.2 feet; thence South 84° 23' East 3.5 feet; thence on arc of 955.0 foot radius curve right (the long chord of which bears South 74° 11 1/2' East) 339.7 feet; thence South 64° 00' East 153.3 feet to Engineers center line Station 503/00. The said center line crossing the East line 269.5 feet South of the East quarter corner of the said Section 22, Township 3 North, Range 36, E.W.M., approximately at Station 501/57.9.
