A parcel of land to be acquired for road right of way, said parcel is located within the Southwest One-quarter of the Southwest One-quarter of Section 29 and the Southeast One-quarter of the Southeast One-quarter of Section 30 and the Northeast One-quarter of the Northeast One-quarter of Section 31 all in Township 3 North, Range 36 East of the Willamette Meridian, Umatilla County, Oregon. Said parcel is a portion of that property described in that warranty deed to Clarence Tubbs and Lois Tubbs, and their heirs and assigns recorded January 27, 1945 in Book 172, Page 539 of the Umatilla County deed records and more particularly described as follows:
