have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide, being thirty feet wide on each side of the center line of the road survey as surveyed over and across the SE 1/4 of SE 1/4 of Section 11, Twp 2N, Range 33, E.W.M., belonging to Ernest M. Temple, as follows: beginning at a point on the North line of the above described property, said point being station 71/22 of the survey; thence proceeding in a southerly direction a distance of 1078 feet to an intersection with the center line of the original right of way County Road No. 747, and containing 1.14 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
