paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet on each side the center line of the Despain Gulch Market road survey as surveyed over and across said property and as more particularly described as follows;

Beginning at a point 1288 feet North of the center of section 18 T. 3 N., R. 32 E. W.M., thence N. 83° 51' W. a distance of 184.0 feet, thence on a 1432.7 foot radius curve right a distance of 432.9 feet, thence N. 66° 38' W. a distance of 3615.6 feet, thence on a 5730 foot radius curve left a distance of 916.7 feet, thence N. 75° 48' W. a distance of 781.2 feet to a point 658.0 feet North of the Quarter section corner common to sections 12 and 13 T. 3 N., R. 31 E. W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

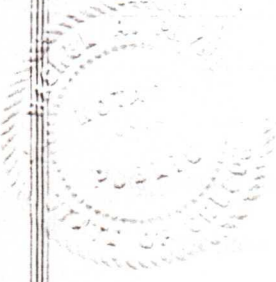
