In the Matter of Accepting Valley View Drive in the subdivision of Rolling Acres, located near McKay Reservoir east of U.S. Hwy. #395 as a County Road.

ORDER ACCEPTING COUNTY ROAD

WHEREAS, Valley View Drive, a street located in the subdivision of Rolling Acres, lying in the SW $\frac{1}{4}$ of Section 27, T2N, R32E, W.M., Umatilla County, Oregon, and said street extending from the south right of way line of County Road 565 to the west right of way line of Lake Drive, and

WHEREAS, on the 10th day of April, 1958, Valley View Drive, a street, was dedicated to the use of the public for road purposes, such street being a strip of land lying thirty (30) feet on each side of a center line, which center line is described as follows:

Beginning at the initial point (viz. NW cor.) of Rolling Acres, which bears S 88° 55' 11"E. 535.00 feet to the Point of Beginning of the said Valley View Drive; thence on 100.00 foot radius curve right (the long chord of which bears S 18° 45' 24"W) 61.70 feet; thence S 36° 26'W. 131.00 feet; thence on 170.00 foot radius curve left (the long chord of which bears S 5° 11' 30"W) 185.39 feet; thence S 26° 03'E. 353.70 feet; thence on 125.00 foot radius curve left (the long chord of which bears N 77° 56' 09"E) 331.67 feet; thence N 1° 55' 17"E. 137.60 feet; thence on 136.18 foot radius curve right (the long chord of which bears N 46° 55' 17"E) 213.91 feet to a point which bears S 1° 55' 17"W. 328.49 feet from the northeast corner of said Rolling Acres.

WHEREAS, said dedication has been duly recorded in Plat Book 8, page 25, paragraph 4, and

WHEREAS, it appears to the Umatilla County Court that the above described public road would be beneficial to the County, and
