BARGAIN AND SALE DEED

THIS INDENTURE WITNESSETH, that the STATE OF ORECON, by and through its State Highway Commission, for the consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to it paid, has bargained and sold and by these presents does bargain, sell and convey unto UMATILLA COUNTY, a political subdivision of the State of Oregon, the following described premises, to wit:

A parcel of land lying in the West half of the Southwest quarter of the Northwest quarter (Wg SW NWW) of Section 3, Township 4 North, Range 28 East, W. M., Unatilla County, Oregon, and being a portion of the following described property: That tract of land which was conveyed by that certain deed to Nellie F. Duvall, recorded in Book 147, Page 19 of Umatilla County Record of Deeds; the said parcel being described as follows:

Beginning at a point which is the intersection of the North Line of the Southwest quarter of the Northwest quarter of Section 3 and the existing right of way line of the Old Oregon Trail Highway; said point being 30 feet distant Southwesterly from (when measured at right angles to) the center line of said highway at Station 480+24.6; said point also being 1505.3 feet South and 183.8 feet East of the Northwest corner of said Section 3, Township 4 North, Range 28 East; thence along said right of way line South 34° 06' East, a distance of 290.4 feet to a point which is opposite and 30 feet distant Southwesterly from center line Station 483+15.0; thence North 89° 55' West, a distance of 150 feet; thence North 34° 06' West, a distance of 290.4 feet to a point on the North line of said property; thence South 89° 55' East along said North line, a distance of 150 feet to the point of beginning, containing 0.83 acre.
