paid them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, for road purposes only

the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land feet wide, being feet on side of the center line of said road, as surveyed over and across

across the Northwest Quarter (NW 1/4) of Section 8 Township 2 North Range 32 East W. M.

Beginning at a point known and designated as Station 3 + 72 on center line of survey for proposed revision, said station being approximately 1290 feet south and 1785 feet west of the quarter section corner common to Section 5 and 8, Township 2 North, Range 32 East, W.M.; thence North 27° 40' East, 40.0 feet, thence North 15° 00' East, 39.0 feet, thence North 62° 44' East, 1011.0 feet, thence North 82° 15' East, 70.0 feet, thence North 76° 14' East, 62.0 feet, thence South 27° 20' East, 43.0 feet, thence South 62° 44' West, 742.0 feet, thence North 87° 16' West, 100.0 feet, thence South 62° 44' West, 455.0 feet, thence North 27° 40' East, 32.0 feet to the place of beginning. Contains 2.41 acres more or less. Same to revert to grantors whenever same ceases to be used for road purposes.
