**WHEREAS**, in accordance with ORS 373.270(1)(a) the Umatilla County Board of Commissioners has determined it to be in the best interest of the County to transfer jurisdiction of County Road No. 1305, Hailey Avenue, from SW 30<sup>th</sup> Street to SW 37<sup>th</sup> Street, and County Road No. 1305, SW 37<sup>th</sup> Street, from Hailey Avenue south to Southgate Place, all located within the corporate limits of the City of Pendleton, Oregon to the City of Pendleton, and

**WHEREAS**, the City of Pendleton and Umatilla County amended their Memorandum of Understanding on October 7, 2005, whereby the County would retain jurisdiction over Goad Road and the City would accept jurisdiction over Hailey Avenue and S.W. 37<sup>th</sup> Street, and

**WHEREAS**, conditions for the transfer of the roads to the City of Pendleton have been met:

**NOW THEREFORE IT IS HEREBY ORDERED** that a hearing is set for March 1, 2006, at 10:10 a.m. in Room 114 of the Umatilla County Courthouse, 216 S.E. Fourth Street, Pendleton, Oregon to hear public testimony both for and against the proposed jurisdiction transfer and determine if the above described roads shall be transferred to the City of Pendleton, Oregon.

**IT IS ALSO ORDERED** that in accordance with ORS 373.270(2)(a) notice of the hearing shall be posted in 3 public places, one of which shall be within the city limits of Pendleton, Oregon. Persons interested in or concerned about this proposed jurisdiction transfer may obtain more information by contacting the Umatilla County Department of Public Works, 3920 Westgate, Pendleton, Oregon, Monday through Friday from 8:00 a.m. through 5:00 p.m., Telephone #(541)278-5424.
