

## CONSENT TO ANNEXATION

TO: THE HONORABLE MAYOR AND COMMON COUNCIL OF THE CITY OF PILOT ROCK, UMATILLA COUNTY, OREGON:

Umatilla County hereby consents to Annexation of the below described property to the City of Pilot Rock for the purpose of allowing PineLam and the Port of Umatilla to annex into the City of Pilot Rock.

The property is the property of Umatilla County and is described as follows, to wit:

County Road No. 1386 (Mill Road-Pilot Rock) for relinquishment of right-of-way to City of Pilot Rock.

Beginning at the Intersection of the Centerline of County Road No. 1388 and 1386, said point of Intersection being  $S11^{\circ}55'50''W$  and 3363.02 ft. distance from the E 1/4 corner of Section 8, Township 1 South, Range 32 East, W.M.; Thence  $N19^{\circ}53'08''E$ , 488.33 ft.; Thence  $N21^{\circ}08'56''E$ , 164.90 ft.; Thence  $N20^{\circ}49'51''E$ , 88.30 ft.; Thence on a 5549.65 ft. Radius Curve to the left (the long chord of which bears  $N11^{\circ}29'55''E$ , 1635.66 ft.) a distance of 1807.83 ft.; Thence on a Spiral Curve (the long chord of which bears  $N6^{\circ}10'12''E$ , 86.96 ft.) a distance of 86.96 ft.; Thence  $N5^{\circ}59'42''E$ , 559.66 ft.; Thence on a 7759.49 ft. Radius Curve to the right (the long chord of which bears  $N6^{\circ}10'51''E$ , 50.33 ft.) a distance of 50.33 ft.; Thence  $N4^{\circ}01'06''E$ , 390.43 ft. to the E 1/4 corner of Section 8, Township 1 South, Range 32 East, W.M., the terminus for this description.

The right-of-way for this description is 60 feet in width 30 feet each side of the above described line.

That said land is contiguous to the City of Pilot Rock, Umatilla County, State of Oregon, and is located within the Urban Growth Boundary and therefore is eligible for annexation.
