GLEN MEADOWS ADDITION TO THE CITY OF HERMISTON

I, J.T. Strank, being first duly sworn, depose and say: That I correctly surveyed and marked with proper monuments as indicated on the accompanying Plat of the GLEN MEADOWS ADDITION TO THE CITY OF HERMISTON located in Umatilla County, Oregon, the lands indicated thereon, that to indicate the initial point of such survey and as shown on said Plat, I placed a 6" x 24" concrete monument six inches below the ground surface at the south-east corner of said land; that said point is located at the center of the NE 1/4 of the SW 1/4 of section 10, T.4N., R.28E., WM, which point is located N.00°-10'E. 1963.35 feet and N.89°-58'W. 660.17 feet from the quarter corner common to sections 10 and 15, which is a known corner established by the United States Survey; that the exterior boundaries of the tract of land upon which said lots are laid out are as follows:

A part of the E 1/2 of the NW 1/4 of the NE 1/4 of the SW 1/4 of section 10, T.4N., R.28E., WM, being more particularly described as follows:

Beginning at the initial point described above; thence N.00°-09'E., along the north-south center line of the NE 1/4 of the SW 1/4 of section 10, 410.41 feet; thence N.86°-34'W. 157.97 feet; thence N.63°-40'W. 191.66 feet to East line of Kather Ave.; thence S.00°-02'W. 750.74 feet to a point on the east-west center line of the NE 1/4 of the SW 1/4 of section 10; thence S.89°-58'E., along said east-west center line, 328.82 feet to the point of beginning.

That I inscribed my registration number on every monument marking every corner I established or reestablished on said land and as shown on said Plat; and that survey and all markings have been done as required by law.

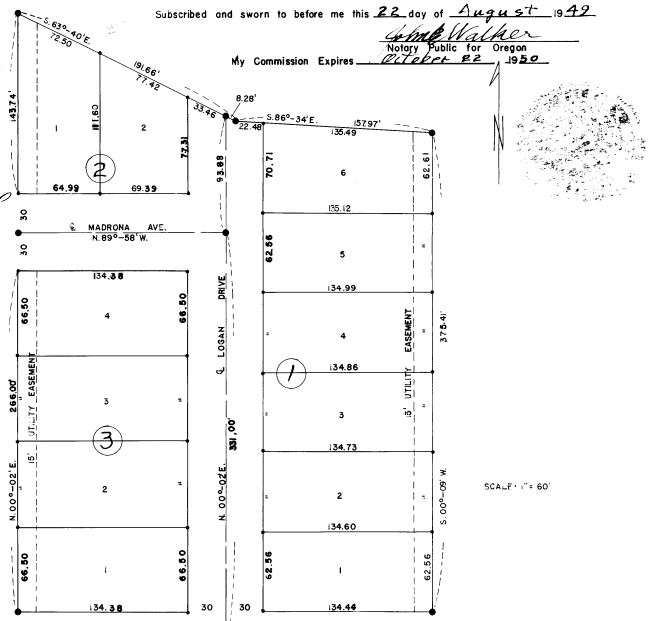
