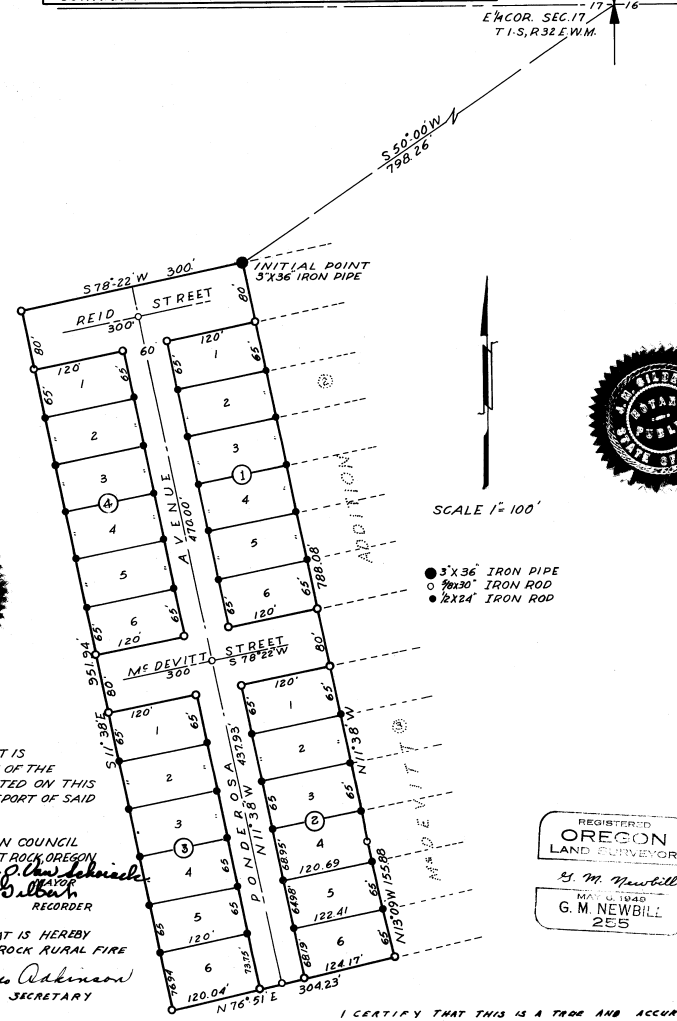

I, G.M. NEWBILL, being first duly sworn, depose and say: That I correctly surveyed and marked with proper monuments as indicated on the accompanying Plat of M^cDEVITT ADDITION NO. 3 TO TOWN OF PILOT ROCK located in UMATILLA County, Oregon, the lands indicated thereon; that to indicate the initial point of such survey and as shown on said Plat, I PLACED A 3X36" IRON PIPE 6' BELOW GRADE AND AS SHOWN ON THE PLAT AT THE NORTHEAST CORNER OF THE PROPERTY, that said point is located SOUTH 50°00' WEST 798.26' FROM THE EAST QUARTER CORNER OF SECTION 17 TOWNSHIP 1 SOUTH RANGE 32 E.W.M. which is a known corner established by the United States Survey; that the exterior boundaries of the tract of land upon which said lots and blocks are laid out are as follows:

BEGINNING AT THE NORTHWEST CORNER OF REID STREET AS SHOWN ON THE OFFICIAL PLAT OF M^cDEVITT ADDITION TO THE TOWN OF PILOT ROCK, OREGON AND RUN THENCE SOUTH 78°22' WEST 30000 FEET; THENCE SOUTH 11°38' EAST PARALLEL TO THE WEST LINE OF BLOCK 2 OF SAID M^cDEVITT ADDITION AND ALONG SAID PARALLEL LINE EXTENDED SOUTHERLY 951.94 FEET TO A POINT ON THE WESTERLY EXTENDED SOUTHERLY LINE OF BLOCK 3 OF SAID M^cDEVITT ADDITION; THENCE NORTH 76° 51' EAST, ALONG SAID EXTENDED LINE 30423 FEET TO THE SOUTHWEST CORNER OF BLOCK 3 OF SAID M^cDEVITT ADDITION; THENCE NORTH 13°09' WEST, ALONG THE WEST LINE OF SAID M^cDEVITT ADDITION, 155.88 FEET; THENCE NORTH 17°38' WEST, ALONG THE AFORESAID WEST LINE 788.08 FEET TO THE POINT OF BEGINNING.

That I inscribed my registration number on every monument marking every corner that I established or re-established on said land and as shown on said Plat and that the survey and all markings have been done as required by law.
