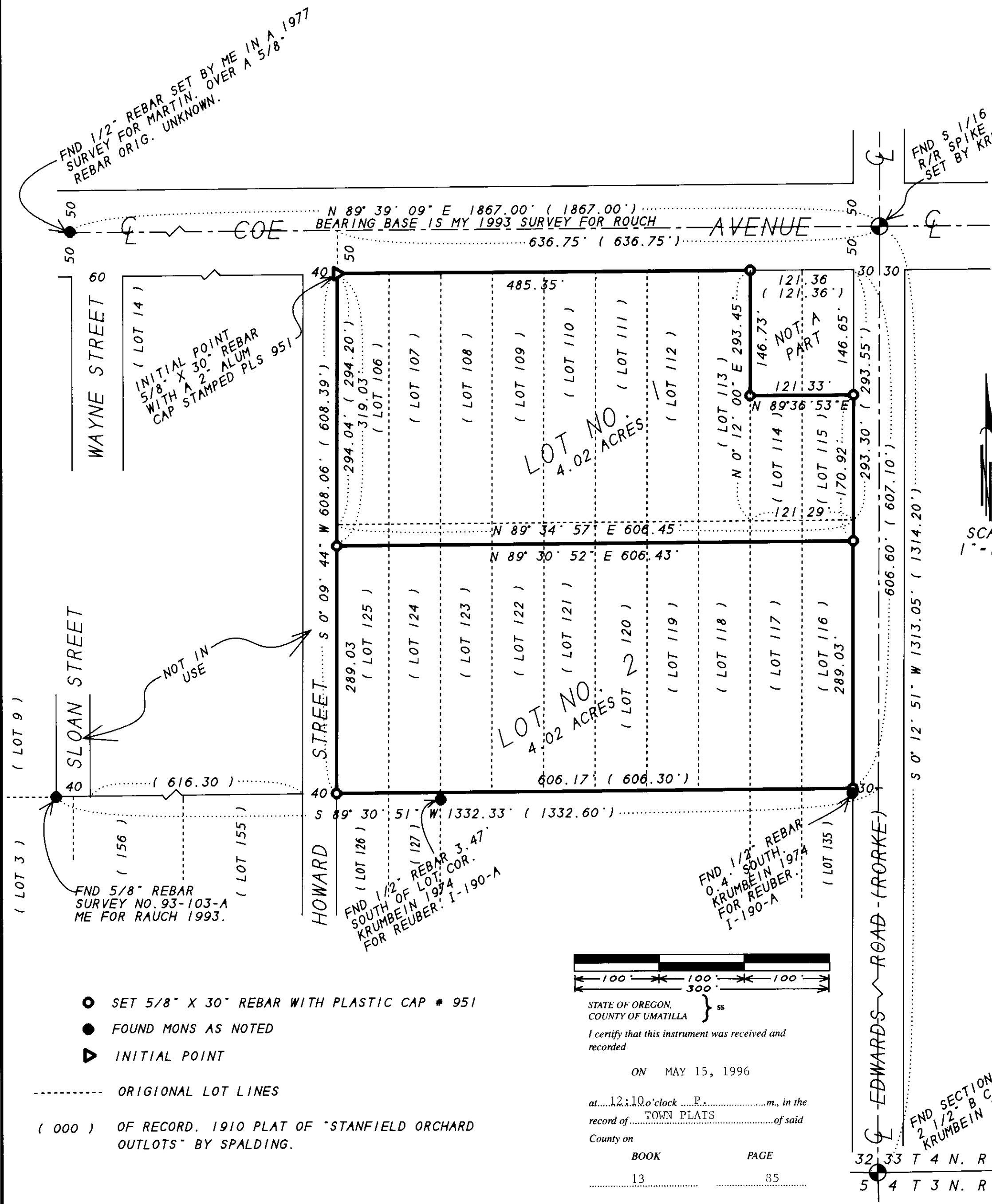


REPLAT OF LOTS 106 THROUGH 125

SURVEYOR'S CERTIFICATE:

I, G. DENNIS EDWARDS, DO DEPOSE AND SAY THAT I HAVE CORRECTLY SURVEYED THE LAND DESCRIBED BELOW AND REPRESENTED ON THE ACCOMPANYING PLAT: THE INITIAL POINT IS A 5/8" X 30" REBAR WITH A 2" ALUM. CAP DRIVEN 6" BELOW THE SURFACE OF THE GROUND AND AT THE NW CORNER OF LOT 106. "STANFIELD ORCHARD OUTLOTS".  
THE DESCRIPTION OF THIS PARCEL IS LOTS 106 THROUGH 125 OF "STANFIELD ORCHARD OUTLOTS", CITY OF STANFIELD, UMATILLA COUNTY, OREGON, RECORDED IN BOOK 4, PAGE 7, UMATILLA COUNTY RECORD OF TOWN PLATS.  
EXCEPTING THEREFROM THE NORTH HALF OF LOTS 114 AND 115.  
I RETRACED SPALDING'S 1910 PLAT OF "STANFIELD ORCHARD OUTLOTS" FROM THE MONUMENTS AS SHOWN, TO SET THE EXTERIOR OF THIS PARCEL. I DID NOT USE KRUMBEIN'S 1974 MONUMENTS (I-190-A) BECAUSE THEY DO NOT MATCH THE 1910 PLAT.

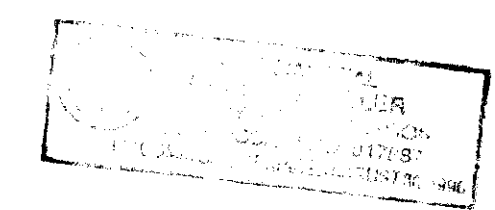

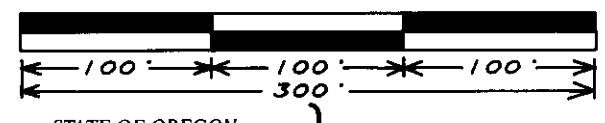
