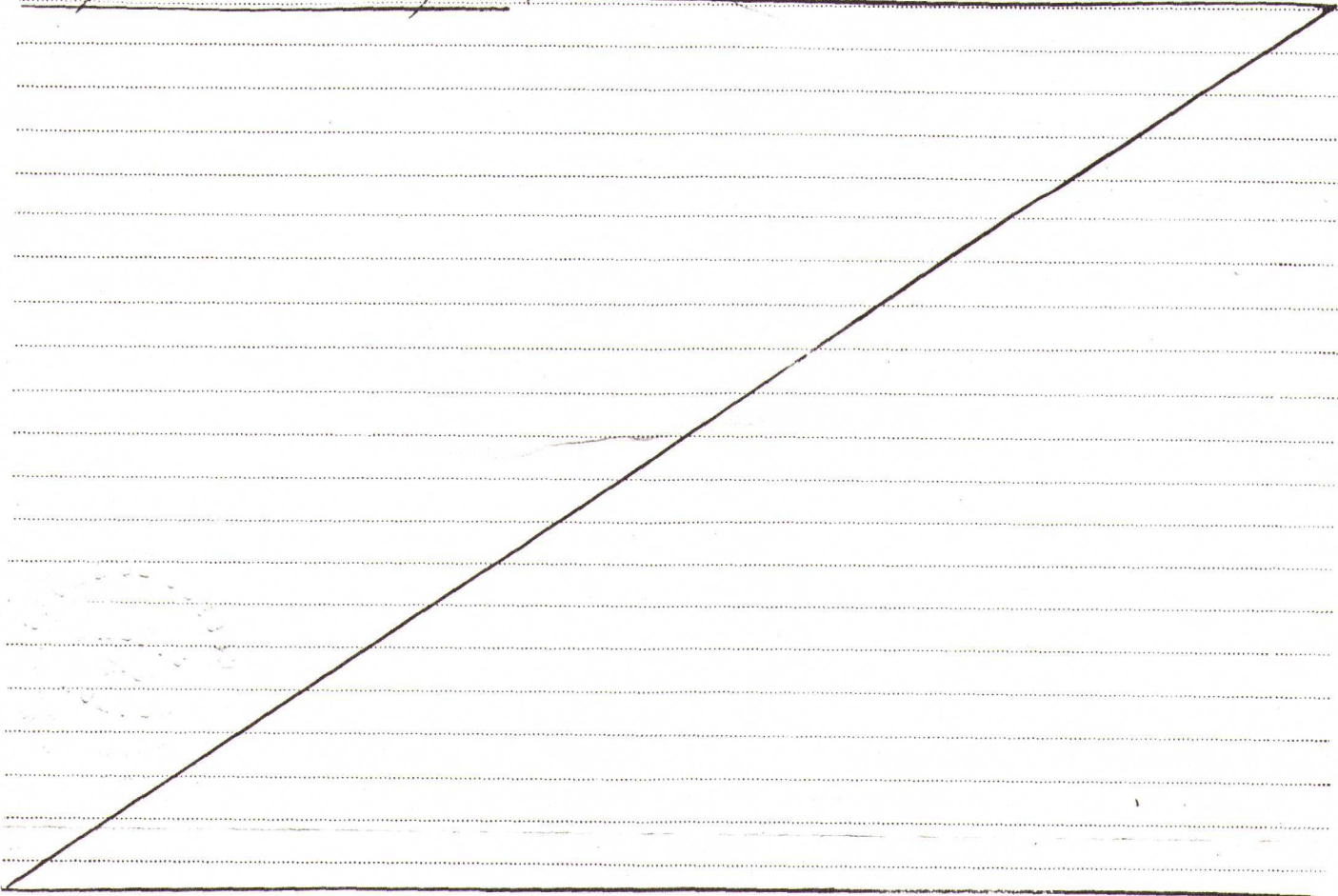

to be used for road purposes forross. the following described premises, ~~to-wit~~ situated in Umatilla County, and State of Oregon, to-wit: Beginning at a point on the State line between the State of Oregon and Washington nineteen (19) rods and Eight and $\frac{3}{4}$ ($8\frac{3}{4}$) feet East of the line between sections fourteen (14) and fifteen (15) in Township Six (6) North of Range thirty-two (32) E. N. W. in said Umatilla County Oregon running thence East along the South side of said State line Eleven and $\frac{3}{4}$ ($11\frac{3}{4}$) rods; thence South fifteen (15) feet; thence West and parallel with said State line Eleven and $\frac{3}{4}$ ($11\frac{3}{4}$) rods; thence North fifteen (15) feet to the place of beginning; Containing $\frac{1}{125}$ of an acre
