in the State of Oregon, to-wit: A strip of land Fifteen (15) feet wide, being Fifteen (15) feet on

the south side of the center line of said road, as surveyed over and across

the Northwest Quarter of Section 15, Township 6 North, Range 35 East, W.M.

Beginning at a point on the State Line 977.0 feet west of the Quarter Section corner on

the north side of said Section 15, thence westerly along said State Line 508.5 feet

of Section Township, Range East W. M.

Beginning at Station of the Highway Survey
