RESOLUTION

County Road No. 878.....

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed to follow the old traveled road from the point where the Government Road intersects the Little Meadows Road northerly along the foot of the hill to a point where the said original Little Meadows road intersects the present traveled road.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of Aug. 19 29, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed road no. 878

shall commence, run and terminate as follows, to-wit:

Beginning at the intersection of the original Little Meadows Road and the Government Mountain Road in Section 12, Township 5 North, Range 37 East, W.M. said point being about 75 feet west of the bridge on the Government Mountain road over the Little Meadows creek, thence in a northerly direction following the original Little Meadows Road along the base of the hill to where the original Little Meadows Road intersects the present traveled road.

The right of way or roadway to be a strip of land sixty feet wide, being thirty feet on each side of the above described line.

Be IT FURTHER RESOLVED that a public necessity for the road or highway is hereby declared to exist for the following reasons, to-wit: it is the old original road that has been traveled by the public for many years and eliminates a very steep hill that is crossed by the road now being used. It is necessary as an outlet to the north for all the mountain country to the east.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular Sept. term for the year 1929 of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon. on the 18th day of Sept. 1929, at 10 o'clock A.M.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk, be posted by Walter M. Ransom as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
