WHEREAS, In accordance with ORS 368.206 the Umatilla County Board of Commissioners issued orders to survey and monument Seven Hills Road, County Road No. 668, lying between Harris Road and Lower Dry Creek Road in Townships 5 and 6 North, Ranges 34 and 35 E.W.M., and that portion of Lower Dry Creek Road lying between Seven Hills Road and County Road in Section 33, Township 6 North, Range 35 E.W.M. and Section 4, Township 5 North, Range 35 E.W.M., and

WHEREAS, the Department of Public Works has found that the roads as traveled and used for ten (10) years or more do not match the existing road records and has recommended that the Board of Commissioners legalize the roads as shown on the survey completed in February, 2003, and

WHEREAS, the Board of Commissioners has determined it to be in the Public interest to legalize the roads, and

WHEREAS, persons interested or concerned about the proposed legalizations may examine said survey and other documents concerning this proposed action by contacting the Umatilla County Department of Public Works , 3920 Westgate, Pendleton, Oregon 97801. ( 541) 278-5424, Monday through Friday, 8:00 a.m. to 5:00 p.m.

NOW THEREFORE IT IS HEREBY ORDERED that a hearing is set for March 19, 2003, at 10:05 a.m. in Room 114 of the Umatilla County Courthouse , 216 S.E. Fourth Street , Pendleton , Oregon to hear public testimony both for and against the proposed legalizations and determine if Seven Hills Road and Lower Dry Creek Road shall be legalized in their present locations as traveled and used for ten ( 10 ) years or more.

IT IS ALSO ORDERED that in accordance with ORS 368.206(1)(c), 368.406, 368.411, and 368.416 those persons whose property abuts said road legalizations shall be notified of this hearing by certified mail at least 30 days before the date of the hearing , notice of the hearing shall be posted in no less than three ( 3 ) public places no later than 20 days before the hearing , and notice of the hearing shall be published in the East Oregonian once at least 20 days before the hearing and once within 10 days of the hearing.

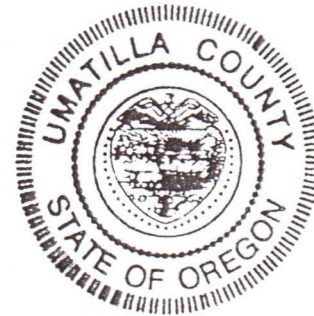
