have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit:

A strip of ground for highway purposes being 60 feet wide, 30 feet on each side of the center line as now surveyed, over and across the S $\frac{1}{2}$ of the S $\frac{1}{2}$ of Section 7, Tp. 3 N. R. 36, E.W.M.; beginning at a point 320 feet north of the SW corner of Section 7, said township and range; thence around a spiral curve to the right the long cord of which bears N 59° 32' E. a distance of 80 feet, more or less, to Engineer's station No. 31+11.0; thence N. 59° 51' E. a distance of 67.8 feet; thence around a 400 foot unit double spiral curve to the right, the long cord of which bears N. 61° 55' E. a distance of 200 feet; thence continuing on a spiral curve to the right, the long cord of which bears N. 74° 19' E. a distance of 200 feet; thence N. 72° 15' E. a distance of 313.9 feet; thence around a 400 foot unit double spiral curve to the left, the long cord of which bears N. 70° 55' E. a distance of 200 feet; thence continuing on the spiral curve to the left the long cord of which bears N. 62° 57' E. a distance of 200 feet; thence N. 64° 17' E. a distance of 251.4 feet; thence around a 300 foot unit double spiral to the right, the long cord of which bears N. 67° 57' E. a distance of 150 feet; thence continuing on the spiral, the long cord of which bears N. 82° 39' E. a distance of 150 feet; thence N. 86° 19.5' E. a distance of 5.7 feet; thence around a 200 foot unit double spiral to the left, the long cord of which bears N. 84° 33.5' E. a distance of 100 feet; thence continuing on the spiral, the long cord of which bears N. 73° 58.5' E. a distance of 100 feet; thence N. 75° 44.5' E. a distance of 18.9 feet; thence around a 200 foot unit double spiral to the right, the long cord of which bears N. 78° 09.5' E. a distance of 100 feet; thence continuing around the spiral to the right, the long cord of which bears N. 87° 48.5' E. a distance of 100 feet; thence S. 89° 46.5' E. a distance of 72.3 feet; thence around a 100 foot spiral curve to the left, the long cord of which bears N. 86° 53.5' E. a distance of 100 feet; thence around a 20° curve (Radius of 286.5 feet) the long cord of which bears N. 60° 24.5' E. a distance of 198.2 feet; thence on a 100 foot spiral curve to the left, the long cord of which bears N. 33° 55.5' E. a distance of 18 feet, more or less, to a point on the East and West line through the S $\frac{1}{2}$ of the S $\frac{1}{2}$ of Section 7, at a point 550 feet more or less East of the Northeast corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 7, Tp. 3 N. R. 36, E.W.M., and containing 3.62 acres.
