each side of the center line of said road, as surveyed over and across
the NE 1/4 of SE 1/4 and SE 1/4 of Sec 1

of Section 1 Township 3 N, Range 35 East W. M.

Beginning at Station 68+55 of the Reed and Hawley Mountain Highway Survey
which Station is approximately 1070 feet due south and _____ feet _____ of the 1/4 Corner
which is common to Sections 6, 7, 8, 9, R. 36 E and Sec 1 Township 3 N, Range 35 East W. M.

Thence running in a Northerly direction approximately 1520 feet to Station 83+75 of
