corner of the Northwest 1/4 of Section 5, Twp. 3 N. R. 36 EWM, thence N. 49°

16' East a distance of 759.3 feet thence around a unit spiral curve to the

right the long cord of which bears N 88° 56' East, a distance of 427.2 feet

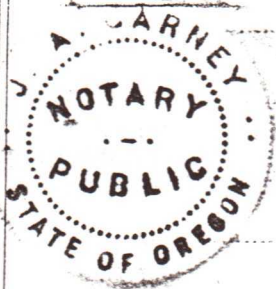
