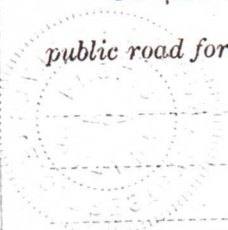

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 35 feet wide, being 5 feet on the west side and 30 feet on the east side of the center line of the road as surveyed over and across the East half of Section 13, T. 4 N. R. 34 E. W.M. Said center line of road being 55 feet East of and parallel to the center line of the Northern Pacific Railway Company's Athena Branch Line and more particularly described as follows; Beginning at a point on the Range Line approximately 1780 feet North of the Southeast corner of Section 13, T. 4 N. R. 34 E. W.M., thence North, 24° 51' West, 2864.7 feet, thence on a curve to the right of Radius 5729.6 feet a distance of 516.7 feet, thence North 19° 41' West, 441.2 feet to a point on the Section Line approximately 980 feet East of the One Quarter Section Corner common to Sections 12 and 13, T. 4 N. R. 34 E. W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
