In the Matter of Locating, Establishing, Altering, Widening, Straightening and Changing a County Road

known as The Athena-Gerking Flat Road

RESOLUTION

County Road No. 55 880

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed known as the Athena-Gerking Flat Road

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of January, 19 29, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed road

shall commence, run and terminate as follows, to-wit:

beginning at a point 178.0 ft. East and 170.4 ft. South of the Northwest corner of the Southwest Quarter of the Northeast Quarter of Section 22, Twp. 4 N. of Rg. 34 E.W.M., running thence in a Northwesterly direction across sections 22, 15, 10, 9 and 4 of Twp. 4 N. of Rg. 34 E.W.M. and Section 33, Twp. 5 N. of Rg. 34 E.W.M. to a point 486 ft. East of the Northwest corner of Sec. 33, Twp. 5 N. of Rg. 34 E. W. M. in Umatilla County, Oregon.

The right of way or roadway to be a strip of land 60 feet wide, being 30 feet on each side of

of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: That it furnishes an outlet for the farm products of a large agricultural community and is part of a road system designated by the formation of Special Road District No. 53.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular February term for the year 1929, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon, on the 7th day of February, 1929, at the hour of 10 o'clock A.M.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk be posted by Walter Ranson, Deputy County Roadmaster, as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
