**WHEREAS**, pursuant to ORS 368.341, the Umatilla County Board of Commissioners received and accepted two petitions, signed by 100 percent of the abutting property owners, to initiate proceedings to vacate a portion of County Road No. 727 (a.k.a. County Road No. 717), Dickerson Road, located in Sections 4, 8, and 9, Township 5 North, Range 34 E.W.M. and Section 33, Township 6 North, Range 34 E.W.M., and

**WHEREAS**, pursuant to ORS 368.346, the Board of Commissioners directed the Public Works Director to prepare and file a written report including a recommendation as to whether the vacation would be in the public interest, and

**WHEREAS**, the Director of Public Works, after reviewing the proposed action, has recommended that the above road be vacated, and

**WHEREAS**, ORS 368.351 allows a county governing body to vacate public property without holding a public hearing if the petition to vacate contains signatures of 100 percent of owners of property abutting a proposed vacation:

**NOW THEREFORE IT IS HEREBY ORDERED** that the following described road be vacated and that all right and title thereto does hereby vest in the owners of the land abutting the vacated property, except that Bonneville Power Administration shall maintain ingress-egress rights over the vacated property for access to their power facilities.

LEGAL DESCRIPTION OF ROAD TO BE VACATED

That portion of County Road No. 727, formerly known as County Road No. 717, lying in the Northeast ¼ of Section 8, Township 5 North, Range 34 E.W.M.; the North ½ of Section 9, Township 5 North, Range 34 E.W.M.; all of Section 4, Township 5 North, Range 34 E.W.M.; and that portion lying in Section 33, Township 6 North, Range 34 E.W.M. southerly of Angle Point 1, as described in the original field notes of County Road No. 717 by Geary Kimbrell, County Surveyor, dated June 28, 1911.
