has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet wide on each side of the center line of said road as surveyed over and across the West Half of the North-west Quarter of Section 20, Township 3 North, Range 35 East, W.M. Said center line being more particularly described as follows; Beging at a point on the East boundary line of said property, said point being 900 feet south and 1320 feet East of the Section Corner common to Sections 17, 18, 19 and 20, thence South 83° 06' West, 238.0 feet, thence on a curve to the left of Radius 5730 feet, a distance of 1095 feet to a point on the Section Line, approximately 990 feet south of the Section Corner common to Sections 17, 18, 19 and 20. All in Township 3 North, Range 35 East, W.M. Contains 1.84 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
