paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: All that part of the property of Richard Thompson and Gladys Thompson, his wife, in the Northeast Quarter of the Southeast Quarter, the Northeast Quarter and the Northeast Quarter of the Northwest Quarter of Section 20, Township 3 North, Range 35 East, W.M. included within a strip of land 60 feet wide being 30 feet wide on each side of the center line of said road as surveyed over and across said property and more particularly described as follows; Begining at a point on the Section line approximately 1050 feet South of the Quarter Section Corner common to Sections 20 and 21, thence North 37 07' West, 810 feet, thence on a curve to the left of Radius 5730 feet, 975 feet, thence North 46 52' West, 1020 feet, thence on a curve to the left of Radius 2864 feet, 2175 feet to a point on the West boundary line of the Northeast Quarter of the Northwest Quarter of Section 20, said point being approximately 390 feet North of the Southwest Corner of the said Northeast Quarter of the Northwest Quarter of Section 20. All in Township 3 North, Range 35 East, W.M.
