Barnes in the S. 1/2 of the S.W. 1/4 of section 22, T.4 N.R.35 E.W.M. included within a strip of land 60 ft. wide being 25 ft. wide on the right and 35 ft. on the left of the center line of the Oregon Washington Highway No. 8, as surveyed over and across said property and as more particularly described as follows:

Beginning at a point in the center of the present traveled County Road 1350.5 ft. North and 1884.3 ft. S. 89° 29' E. of the corner of sections 21, 22, 27 and 28, T.4 N.R.35 E. W.M. Umatilla County; State of Oregon; thence on a 4° curve to the right whose central angle is 6° 08' 153.3 ft.; thence S. 83° 21' E. 456.6; thence on a 28° curve to the left whose central angle is 97° 37' 180.8 ft. to the center line of the present traveled County Road 135.5 ft. North and 2653.5 ft. S. 89° 29' E. of the corner of sections 21, 22, 27 and 28, T.4 N.R.35 E.
