Russell would be rendered by reason of the location of the above mentioned road as a County Road for final hearing. the same having been read on a previous day of this term of this Court to-wit: Jany term 1884. and it appearing from said report that said viewers duly met at the time and place appointed and were duly qualified before entering upon the discharge of their duties in this behalf. and it further appearing from said report that the said viewers have estimated and appraised the damage sustained to the land of A. C. Russell, at the sum of \$100.

And it also appearing to the Court that the viewers heretofore appointed to view out and report upon the location of the above mentioned road, duly made their report at the Sept term 1883 of this Court and that said viewers reported favorably and recommend the location of the same as a County Road and the field notes and plat of survey of said road being duly on file and certified to by the Surveyor appointed to survey the same and there being no remonstrance on file against said road.

It is therefore ordered by the Court that the report of said viewers be accepted and that the road be established in accordance with said report and that the report of said viewers field notes and plat of survey thereof be recorded as by law required upon payment by the petitioners herein to
