has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide being thirty feet on each side of the center line of the Despain Gulch Market Road as surveyed over and across the Southwest Quarter of Section 3 Township 3 North, Range 31 East W.M. and as more particularly described as follows:

Beginning at a point on the section line 98.0 feet West of the Quarter Section corner common to sections 3 and 10 Township 3 North, Range 31 East W.M. which point is known and designated as station 311/74.3 thence North 63°32' West 1130.0 thence on a 1146.0 foot radius curve right 641.7 feet, thence North 31°27' West 332.2 feet, thence on a 2865.0 foot radius curve right 758.3 feet, thence North 16°17' West 665.9 feet, thence on a 2865.0 foot radius curve right 144.0 feet to a point known and designated as station 348/46.4 which point is 326.0 feet East of the Quarter Section corner common to Sections 3 and 4 Township 3 North, Range 31 East W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
