

In County Court July term 1884  
10<sup>th</sup> Judicial day Thursday July 31<sup>st</sup> 1884

In the matter of a County Road commencing  
at a stake driven at the S.W. Cor of Sec 24  
Tp 4 N. R 30 E. thence W 6 miles to the S.W. Cor  
of Sec 24 Tp 4 N. R 29 E. thence S. 1/2 mile to  
the point of termination, designated by a stake  
driven at the point of termination of County  
Road N<sup>o</sup> 172, near the 1/4 Sec post between Sec  
25<sup>th</sup> & 26 Township 4 N. R. 29. East

Road N<sup>o</sup> 199.

Now on this day comes the report  
of the viewers here to fore appointed at the April term 1884 of this Court  
to view out <sup>and</sup> report upon the location of the above mentioned road as a County  
Road for final hearing, the same having been read upon a previous day of  
this term of this Court to-wit: July term 1884. <sup>and</sup> the said viewers having reported  
favorably <sup>and</sup> recommending the establishing of the same as a County Road,  
<sup>and</sup> the field notes <sup>and</sup> plat of survey being duly on file <sup>and</sup> certified to by the  
surveyor appointed to survey the same, <sup>and</sup> there being no remonstrance  
on file against said road.

It is therefore ordered by the Court that said road be established as a  
County Road in accordance with the report <sup>and</sup> that the report of said viewers  
of survey thereof be recorded as by law required, <sup>and</sup> the Supervisor of the  
District through which said road runs be ordered <sup>and</sup> directed to open the  
same as a County Road.

In the matter of a County Road commencing  
at a point where the East line of Sec 35 Tp  
4 N. R 20 E. running down State Canyon,  
thence North to the S.E. Cor of Sec 26 Tp 5 N. R 30  
E. thence West on Sec line between Sec 26 <sup>and</sup>  
35; thence N.W. down a Canyon to intersect  
a Road running down Main Cold Spring Canyon

Now on this day comes the  
report of the viewers heretofore appointed at the April term 1884 of this  
Court to view out <sup>and</sup> report upon the location of the above mentioned road as  
a County Road for final hearing, the same having been read upon a previous  
day of this term of this Court, to-wit: July term 1884. <sup>and</sup> the said viewers having  
reported favorably <sup>and</sup> recommending the establishing of the same as a  
County Road, <sup>and</sup> the field notes <sup>and</sup> plat of survey being duly on file <sup>and</sup> certified  
to by the surveyor appointed to survey the same. <sup>and</sup> there being no remon-  
strance on file against said road.
