Know all men by these presents, That I, Almira E. Hawks,

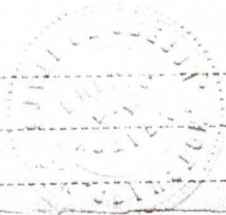
of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to her the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land sixty feet wide, being thirty feet wide on each side of the center line of said road as surveyed over and across the Northwest Quarter of Section 3 and the Southeast Quarter of Section 4, Township 2 North, Range 31 East, W.M. and more particularly described as follows; Beginning at a point known as station 0 / 00, which point is 1116 feet East of the Northwest Corner of said Section 3, thence running southwesterly following the said road survey 2347 feet to a point known as Station 28 / 47, which point is 320 feet East of the Quarter Section corner common to Sections 3 and 4, T. 2N. R. 31 E. W.M. Also, beginning at a point known as Station 35 / 77, which point is 667 feet South of the Quarter Section Corner common to said Sections 3 and 4, thence, running Southwesterly following the said road survey 2457 feet to a point known as Station 60 / 34, which point is 446 feet West of the Section corner common to Sections 3, 4, 9 and 10, Township 2 North, Range 31 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
