have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land _____ feet wide, being _____ feet on _____ side of the center line of said road, as surveyed over and across

30 feet Wide on the North side of center line station 192+00 to Sta. 194+00 - 25 feet Wide on east side and 35 feet wide on west side of center line station 194+00 to 198+00 25 feet wide on east side of center line station 198+00 to station 213+00 as surveyed and staked over and across a portion

of Section 9 Township 3-N, Range 30 East W. M. Beginning at Station 192+00 of the Echo - Stage Gulch Highway Survey which Station is approximately 687 feet East and _____ feet of the section Corner which is common to Sections 8-9-16-17 Township 3-North Range 30 East W. M. Thence running in a North easterly direction approximately 2100 feet to Station 213+00 of the said survey, which Station is approximately 856 feet North and 2080 feet East of the section corner which is common to Sections 8-9-16-17 Township 3-N Range 30 East W.
