

IN THE COUNTY COURT OF THE STATE OF OREGON FOR
UMATILLA COUNTY.

Road No. 867. : ORDER.

Now on this day this matter coming on for hearing upon the report of County Road Viewers, said report having been publicly read the first time on August 4th, 1926, and publicly read the second time on August 5th, 1926, and there being no remonstrances or objections on file against said petition, or report of the Board of County Road Viewers, and said Board of Viewers having reported favorably and recommended that said road be laid out and established as a County Road of Umatilla County, Oregon upon the following described route.

Following closely the description in the above mentioned petition and having the same termini, will make a feasible and necessary road and one beneficial to the public; Beginning at the Quarter Section corner common to Sections 12 and 13, Township 4 North, Range 28 East, W.M. thence running Northeasterly following a straight line as closely as practicable to a crossing over the U.S. Feed Canal at the reverse curve in said Feed Canal in the South Half of the Northwest Quarter of Section 8, T. 4 N. R. 29 E.W.M., thence crossing said U.S. Feed Canal and continuing Northeasterly, following a straight line as closely as practicable to a point on the East and West 1/16 section line through the middle of the North half of Section 9, T. 4 N. R. 29 E.W.M. Said point being approximately

150 feet East of the center of the said U.S. Feed Canal, thence East, following the above mentioned 1/16 Section line through Section 9, T. 4 N. R. 29 E.W.M. to a point in the Northwest Quarter of Section 10, T. 4 N. R. 29 E.W.M. 30 feet North of the North right of way line of the Furnish Ditch, thence easterly following a line 30 feet north of and parallel to the north right of way line of the said Furnish Ditch to an intersection with the East and West 1/16 Section line through the middle of the North half of Section 10, T. 4 N. R. 29 E.W.M. thence East following the above mentioned 1/16 Section line through Sections 10 and 11, T. 4 N. R. 29 E.W.M. to the Southeast Corner of the Northeast Quarter of the Northeast Quarter of Section 11, T. 4 N. R. 29 E.W.M. thence Southeasterly to the Quarter Section corner common to Sections 12 and 13, T. 4 N. R. 29 E.W.M. Said road to be sixty feet wide, being thirty feet wide on each side of the above described center line. excepting through and across Section 9, T. 4 N. R. 29 E.W.M. said road to be sixty feet wide, being 12 feet wide on the north side and 48 feet wide on the south side of said above described center line.

IT IS THEREFORE HEREBY ORDERED that said report of the Board of County Road Viewers be adopted in full, and that said road be declared a public highway of Umatilla County, Oregon along the route as recommended by said Board of County Road Viewers, and that the same be finally surveyed in accordance with the law.
