(1) Beginning at a point on the center line of said highway, sta. 16 / 60, which point is the intersection of the center line of said highway and the section line between Sec. 16 and Sec. 21, Tp. 3 North, Range 29 E. W. M., and is approximately 350.0 feet west of the section corner common to sections 15-16-21-22, Tp. 3 North, Range 29 E. W. M.; thence a distance of 24 feet as measured East along said section line; thence a distance of 351.8 feet as measured southeasterly along east right of way line of said highway bearing South 32 deg. 09' East; thence a distance of 152.1 feet as measured southeasterly along east right of way line of said highway, a 1452.5 feet radius curve line to right; thence a distance of 30.0 feet as measured southeasterly along said east right of way line bearing South 26 deg. 09' East; thence a distance of 106.5 feet as measured southeasterly along said east right of way line, a 1412.5 feet radius curve line to left to a point on the section line between Section 21 and 22, Tp. 3 N., Range 29 E. W. M., which point is 20 feet distant, as measured North-easterly along radial line of 4 deg highway curve, from center line of highway sta. 23 / 12.9; thence a distance of 44.0 feet as measured south along said section line to a point which is the intersection of said section line and east right of way line of the O-W. R. & N.Co.; thence a distance of 702.5 feet as measured northwesterly along said railroad right of way line bearing S. 32 deg. 11' East to a point which is the intersection of said east right of way line and the section line between Sec. 16 and 21, Tp. 3 North, Range 29 E.
