FLEETWOOD ENTERPRISES, INC., a California corporation, conveys to UMATILLA COUNTY, a municipal corporation, all that real property situated in Umatilla County, State of Oregon, for the sole use by the public as a county road, described as:

TRACT A

Beginning at the Southeasterly corner of that tract of land belonging to Fleetwood Enterprises, Inc., as recorded on Page 610, Book 294, of the Deed Records of Umatilla County, Oregon; thence South 54° 10' 22" West along the Southerly line of said Fleetwood Tract 127.02 feet; thence South 57° 06' 15" West continuing along said Southerly line 206.61 feet to a point North 32° 53' 45" West 25.00 feet from Engineers centerline station 18 + 17.8; thence Northeasterly along a 929.93 foot radius curve to the left, the chord bears North 47° 11' 40" East 320.02 feet, a distance of 321.62 feet, to a point North 52° 42' 50" West 25.00 feet from Engineers center line station 21 + 48.1; thence North 37° 17' 10" East 23.15 feet to a point on the Easterly line of said Fleetwood tract; thence South 29° 17' 10" East along said Easterly line 56.54 feet to the point of beginning.

All being in the SE 1/4, NW 1/4, Section 8, Township 2 North, Range 32 East, W.M., County of Umatilla, State of Oregon.

TRACT B

Beginning at the Southwesterly corner of that tract of land belonging to Fleetwood Enterprises, Inc., as recorded on Page 610, Book 294 of the Deed Records of Umatilla County, Oregon; thence North 25° 30' 15" West along the Westerly line of said Fleetwood tract 31.96 feet to Engineers centerline station 14 + 00.5; thence continuing North 25° 30' 15" West along said Westerly right-of-way 27.35 feet; thence Northeasterly along a 384.26 foot radius curve to the left, the chord bears North 73° 09' 50" East 212.62 feet, a distance of 215.43 feet to a point North 32° 53' 45" West 25.00 feet from Engineers centerline station 16 + 18.5, said point being on the Southerly line of said Fleetwood tract; thence South 57° 06' 115" West along said Southerly line 211.95 feet to the point of beginning.



All being in the SE 1/4, NW 1/4, Section 8,  
Township 2 North, Range 32, East, W.M., County  
of Umatilla, State of Oregon.

The true and actual consideration for this transfer  
is no cash, but is the acceptance by Umatilla County as a

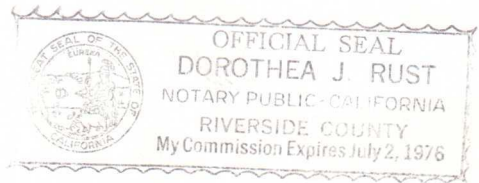
