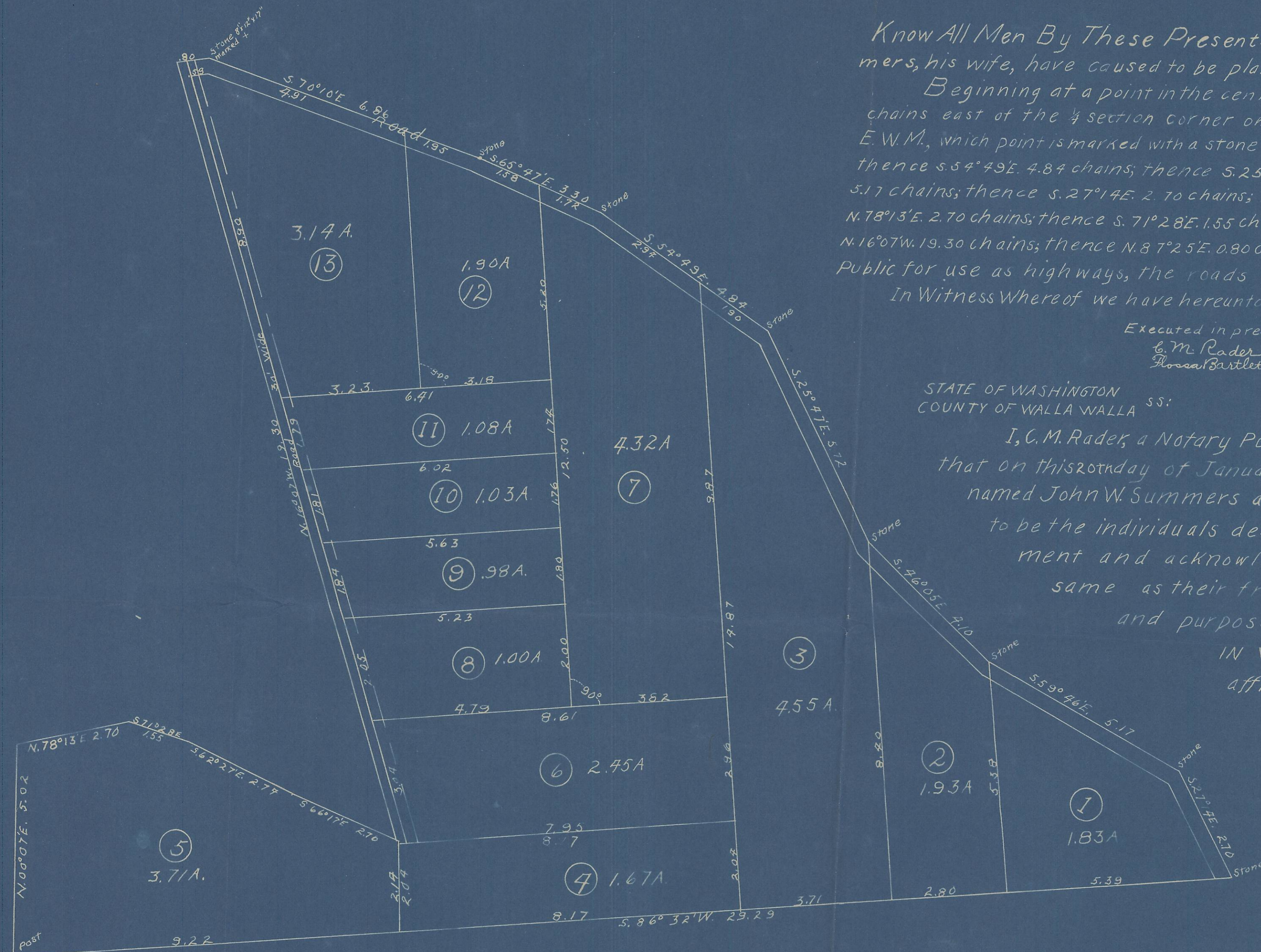


VALLEY VIEW ORCHARD TRACTS



Know All Men By These Presents, That John W Summers and Jennie B Summers, his wife, have caused to be platted into tracts and roads the following described land: Beginning at a point in the center of the County Road 0.59 chains north and 45.7 chains east of the $\frac{1}{4}$ section corner on the north side of Section 18, Township 5 North, Range 37, E. W. M., which point is marked with a stone 8" x 12" x 11"; thence S. 70° 10' E. 6.86 chains; thence S. 65° 47' E. 3.30 chains; thence S. 54° 49' E. 4.87 chains; thence S. 25° 47' E. 5.72 chains; thence S. 46° 05' E. 4.10 chains; thence S. 59° 46' E. 5.17 chains; thence S. 27° 14' E. 2.70 chains; thence S. 86° 32' W. 29.29 chains; thence N. 0° 07' E. 5.02 chains; thence N. 78° 13' E. 2.70 chains; thence S. 71° 28' E. 1.55 chains; thence S. 62° 27' E. 2.74 chains; thence S. 66° 17' E. 2.76 chains; thence N. 16° 07' W. 19.30 chains; thence N. 87° 25' E. 0.80 chains to the point of beginning, and hereby dedicate to the Public for use as highways, the roads as shown herewith.
