I, R.T. Longhorn, being duly sworn do testify and say that I have correctly surveyed and platted the land as represented by the accompanying plat, the exterior boundaries of which are described as follows:

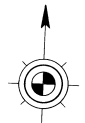
Starting at the NW corner of the SW 1/4 of the NW 1/4 Sec 11 T4N, R28E WMM, which is the point of beginning, thence running S0°20'E along the west line of said SW 1/4 of the NW 1/4, 510 feet; thence N89°30'E parallel to the north line of said SW 1/4 of the NW 1/4, 50 feet to the initial point. Thence N 89°30'E, 777.4 feet; thence N0°20'W parallel to the west line of said SW 1/4 of the NW 1/4, 345 feet; thence N89°30'E, 492.6 feet; thence N0°20'W, 165 feet to the NE corner of the said SW 1/4 of the NW 1/4; thence S89°30'W on the north line of said SW 1/4 of the NW 1/4, 1320 feet to the point of beginning.

Excepting: Beginning at the NW corner of said SW 1/4 of the NW 1/4 thence S0°20'E, 10 feet; thence northeasterly 1320 feet more or less to the NE corner of said SW 1/4 of the NW 1/4; thence S89°30'W, 1320 feet to the point of beginning.

I have marked the ground with proper monuments, the subdivisions as represented, by staking and by placing iron pins at all boundary and subdivision points.
