I, W.E.O. Criger, being first duly sworn, on oath say; that I have correctly surveyed and platted the land as represented by the accompanying plat of Cary and Mills Addition to the City of Freewater, Oregon; the exterior boundaries of which are described as follows:— From the S.W. Corner of the N.W. 1/4 of the N.E. 1/4 of Section 2, T. 3N., R. 35 E., W.M., thence North on the West Line of said N.W. 1/4 of N.E. 1/4 of Sec. 2, 579.55 Feet, thence East and parallel with the North Line of Sec. 2, 302 Feet to the point of beginning, and at which point I planted a 2 inch iron pipe three feet long, the top thereof being driven below the surface of the ground six inches, in accordance with section 19-1304, Oregon Code, annotated; thence North and parallel with the W. Line of the N.W. 1/4 of N.E. 1/4 of Sec. 2, 180 Feet; thence E. and parallel with the N. Line of Sec. 2, 382.5 Feet; thence South and parallel with the W. Line of N.W. 1/4 of N.E. 1/4 of Sec. 2, 220 Feet; thence West and parallel with the N. Line of Sec. 2, 216.5 Feet; thence N. and parallel with the W. Line of N.E. 1/4 of Sec. 2, 152 Feet; thence West and parallel with the N. Line of Sec. 2, 66.5 Ft., thence North and parallel with the W. Line of N.E. 1/4 of Sec. 2, 25.5 Ft., thence W. and parallel with the N. Line of Sec. 2, 100.5 Ft., to the point of beginning. Each corner of all lots is marked with an iron pin.

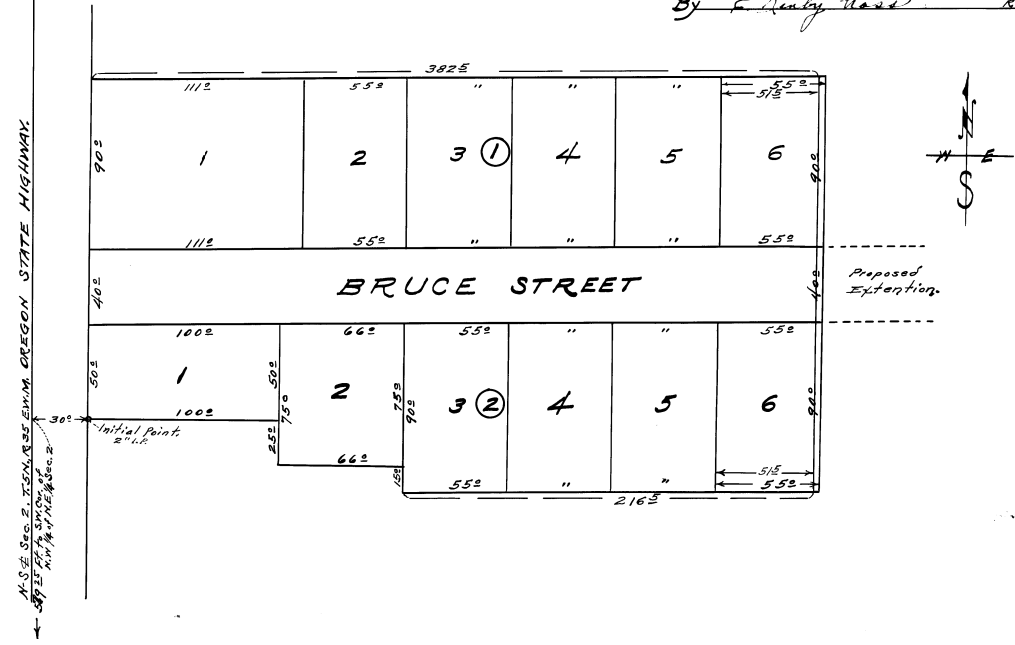
